### 2. CONTRACT<sup>2</sup>

  - (i) Schedule 1: Deliverables Specifications;
  - (ii) Schedule 2: General Terms and Conditions;
  - (iii) Schedule 3: Specific and Local Terms and Conditions;

### 3. PRIORITY OF DOCUMENTS

The Contract Documents are to be taken as mutually explanatory of one another. If there is any ambiguity or discrepancy in the Contract Documents, the Company shall issue the necessary clarification or instruction to the Contractor, and the priority of the Contract Documents shall be as follows:

- (a) this Agreement Document (without the schedules)
- (b) Schedule 3: Specific and Local Terms and Conditions;
- (c) Schedule 2: General Terms and Conditions;
- (d) Schedule 1: Deliverables Specifications;
- (e) Schedule 4: Schedule of Quotations;
- (f) Schedule 5: Payment Schedule;
- (g) Schedule 6: Milestones;
- (h) Schedule 8: Contractor Insurances;
- (i) Schedule 7: Securities; and

### 4. CONSIDERATION

- 4.1 In fair and good consideration of the payment to be made under the Contract by the Company to the Contractor, the Contractor hereby covenants with the Company to execute and complete the Deliverable(s) in conformity with the provisions of the Contract.
- 4.2 The Company will pay the Contractor in consideration of the execution and completion of the Deliverables the Contract Price [of THB amount]]<sup>5</sup> in the manner set out in Schedule 5.

### 5. SECURITIES AND CONTRACTOR INSURANCES

- 5.1 The Contractor shall provide the Company the following securities, meeting the requirements set out in clause 13 of Schedule 3, within thirty (30) days from the date of the Contract, failing which the Company shall be entitled to, without prejudice to any other rights and remedies of the Company, instruct the Contractor to immediately suspend the execution of the Deliverables until all the securities are provided:
  - (a) As set out in Schedule 6
- 5.2 The Contractor shall provide the Company, the following copies of the following Contractor Insurances or insurance certificates, meeting the requirements under clause 15 of Schedule 3, within two (2) weeks from the date of the Contract, failing which

the Company shall be entitled to instruct the Contractor to immediately suspend the execution of the Deliverables until such insurances are put in place:

All sums due to Contractor under the Contract shall also be subject to any deductions or withholding taxes, service level enhancement, and contributions whatsoever and penalties or interest thereof which may be required under the laws in force in the Kingdom of Thailand

The Contractor must submit irrevocable and unconditional bond and ESCO shall be entitled to make a demand on and utilize the proceeds of the Bond at ESCO's sole discretion.

For any or all of the Bond, ESCO shall return the original copy thereof to the Contractor, and issue certificate(s) of release notes thereof duly signed and executed by the authorized representative of the Seller.
